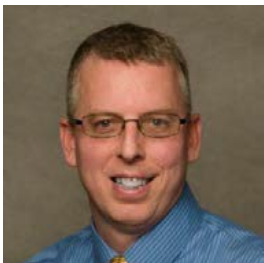


Diane Oremovich, Assisted Living Cabinet President

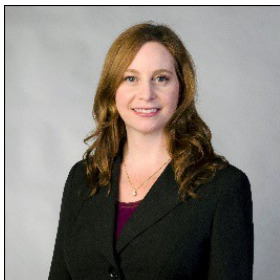
