Technician On-site To Perform Qualitative Fit Testing (QLFT): Pricing based on volume and location

- Up to 96 tests/day. Sessions begin every 30 minutes

A QLFT is a pass/fail fit test that assesses the adequacy of respirator fit based on the individual’s response to a test agent. A QLFT may be used for all tight fitting negative pressure facepieces that will be used in atmospheres up to 10 times the OSHA PEL. As part of conducting the fit test, technicians will conduct a user seal check on each respirator that is fit tested. QLFT is conducted using our fit test kits and the test agent Saccharin Solution Aerosol or Bitrex™ Solution Aerosol.

All employees to be fit tested must be clean-shaven. Each employee must be in possession of, and fit tested on, his or her own respirator at time of testing. Surrogates, or back-up respirators, must be provided by the client and on hand and available for use at the customer’s premises on the day of testing.
