#### **Grassroots Advocacy**

LeadingAge Illinois strongly believes that legislative victory is most likely achieved in many voices sounding a single note. Thus LeadingAge Illinois initiates and supports grassroots lobbying efforts with LeadingAge Illinois member organizations. LeadingAge Illinois staff will work with members to plan legislative receptions at their communities as part of the Partners in Quality initiative. Partners in Quality Legislative visits allow legislators to witness firsthand the quality care and services you provide to older adults and gives them a better understanding of industry issues. Believe it or not, there are legislators who have never been inside a senior living community and don't have the knowledge of the different provider settings!

#### Spirit-PAC

The Spirit Political Action Committee (SPIRIT-PAC) is a bipartisan, voluntary, not-for-profit organization representing professional men and women in the field of long term care and retirement housing. Affiliated with LeadingAge Illinois, SPIRIT-PAC was created to support LeadingAge Illinois' friends in the Illinois Legislature and also to gain access to those legislators who may not be current on issues affecting our profession.

Responses to the 2014 LeadingAge IL Annual Salary & Benefits Survey provided the information needed to generate our 2014 LeadingAge Member Staff Turnover and Vacancy Report. This report is provided complimentary to all members and highlight the continued issue of workforce management for members. A total of 152 organizational members participated in the 2014 Salary Survey (8% increase from 2013), and 121 of those organizations (80%) provided turnover data for this year's report.
