### **Tool: Room Change Policy and Procedure Checklist**

# Multiple areas in the Final Rule reflect the room change criteria § 483.10 Resident Rights

The facility must also promptly notify the resident and the resident representative, if any, when there is a change in room or roommate assignment as specified in § 483.10(e)(6); The right to receive written notice, including the reason for the change, before the resident's room or roommate in the facility is changed. The right to refuse to transfer to another room in the facility, if the purpose of the transfer is: To relocate a resident of a SNF from the distinct part of the institution that is a SNF to a part of the institution that is not a SNF, or to relocate a resident of a NF from the distinct part of the institution that is a SNF to convenience of staff. A resident's exercise of the right to refuse transfer does not affect the resident's eligibility or entitlement to Medicare or Medicaid benefits.

#### § 483.15 Admission, transfer, and discharge rights.

A facility that is a composite distinct part must disclose in its admission agreement its physical configuration, including the various locations that comprise the composite distinct part, and must specify the policies that apply to room changes between its different locations under § 483.15(c)(9). *Room changes in a composite distinct part.* Room changes in a facility that is a composite distinct part (as defined in § 483.5) are subject to the requirements of § 483.10(e)(7) and must be limited to moves within the particular building in which the resident resides, unless the resident voluntarily agrees to move to another of the composite distinct part's locations.

# Purpose and Intent of § 483.10 Resident rights and § 483.15 Admission, transfer, and discharge rights.

The facility policy guides the practices that promote the residents' rights related to room change and change of roommate and educates and informs staff practices for appropriate room changes and roommate changes. The policy defines facility actions to protect the rights of residents to refuse room changes to or from singularly certified SNF or NF parts of the facility solely for the convenience of the staff. Residents residing in a composite distinct part of the facility will be moved only in the particular building in which the resident resides, unless the resident voluntarily agrees to move to another of the composite distinct part's locations.

To assure that the individual facility has followed all the required steps for the development and implementation of a comprehensive room change policy in accordance to the new Requirements of Participation (RoP), the following checklist captures specific action items for successful completion. The far left column represents the actual Requirements of Participation





(RoP) language and the right column indicates specific leadership strategies for successful completion and implementation of the revised RoP. When preparing updated policies and procedures, it is recommended to include actual RoP language as applicable. Please note that CMS has not issued its interpretative guidance for the new Requirements of Participation (RoP), therefore additional updates may be necessary once the guidance is released.
